This is the privacy statement of UCI Union Ceramics International (hereinafter referred to as UCI). In this statement we explain, among other things, why we collect and use personal data, what data that is and what rights you have when we process your personal data.

COOKIES

When you visit our website, we process your personal data with cookies. We use technical cookies to make the website function. We also use a program for website statistics, but we anonymize your data as much as possible. Read more in our Cookie Statement.

WHY DO WE PROCESS PERSONAL DATA?

We process personal data to perform our task as a supervisory authority for the protection of personal data. For example, we investigate possible violations of the General Data Protection Regulation (GDPR) and handle privacy complaints. We process personal data if this is necessary.

WHAT DATA DO WE COLLECT AND USE?

If we collect and use your personal data, it is usually because you have contacted us yourself. And you have provided information about yourself. For example, if you report a privacy complaint or a data breach.

But it is also possible that your personal data appears in our files without you having provided this information yourself. For example, because we are investigating your organization on our own initiative or because someone has submitted a complaint about you. We may also collect and record information from public sources.

MAY WE PROCESS YOUR PERSONAL DATA?

As UCI, we are only allowed to use personal data for a reason stated in the privacy legislation. Such a reason is called a basis. The possible grounds can be found in Article 6 of the General Data Protection Regulation (GDPR).

Other legal bases on which we process personal data are consent of the data subject (Article 6(1)(a) of the GDPR) and compliance with a legal obligation (Article 6(1)(c) of the GDPR).

PERMISSION

Do we process your personal data based on your consent? Then you can withdraw your consent at any time. From that moment on, we no longer process your personal data. Unless there is (also) another basis for processing your data.

SPECIAL OR CRIMINAL DATA

Do we process special personal data (such as medical data) or criminal personal data about you? Then we may do so because of the important public interest (Article 9, second paragraph, preamble and under g of the GDPR in conjunction with Article 32, preamble and under e in conjunction with Article 23, preamble and under b of the GDPR).

HOW DO WE SECURE YOUR DATA?

We take both technical and organizational measures to secure the personal data we process. So that this data is not lost, for example. We do this in accordance with the applicable legal requirements and guidelines.

An example of a technical measure is that your data is sent via a secure connection if you use an online form on the website of UCI. Your data is also encrypted during transmission. This means that your data will be unreadable should it fall into the wrong hands.

An example of an organizational measure is that only authorized employees of UCI may view your data. And these employees only have access to your personal data to the extent necessary to perform their duties.

HOW LONG DO WE KEEP YOUR DATA?

We do not store your personal data for longer than is necessary for the purpose for which we process your data. But sometimes we are obliged to keep your data longer. For example, if this is stated in the Archives Act.

DO WE SHARE YOUR DATA WITH THIRD PARTIES?

To be able to perform our legal tasks, it may be necessary to share data with other parties (third parties). This can be within the Netherlands as well as within the European Union (EU). Or sometimes beyond. If we share your data outside the EU, we will inform you separately.

For example, we may share data with other regulators and the Public Prosecution Service. We only do this if permitted by law. Or if we have a cooperation agreement. And it is necessary to share data to perform our duties or comply with a legal obligation.

WHAT ARE YOUR RIGHTS?

You have a number of privacy rights. For example, you can ask us which personal data we process about you. And if the data is not correct, have it corrected. In some cases, you can also ask us to delete, transfer or restrict the processing of your data.

Finally, you can object to the processing of your data. And do you disagree with how we process your data? Then you can report a privacy complaint to us.
